Assumption of Risk and Indemnity Agreement**



In consideration for allowing me and/or my minor to enter and enjoy the Park™, myself and my minor, our personal representatives, heirs, next-of-kin, spouses and assigns, HEREBY:

1. Acknowledge that such Attractions at the Park™ are inherently dangerous and irrational creatures, and may change their behavior at any moment, leading to injury or infection. Attractions at this park may kick, bite, spit, trample, crush, drown, or otherwise harm patrons. Any extracurricular activities with such Attractions does not entitle a patron to additional medical care.
2. Agree that items such as firearms, edged tools, performance enhancing pharmaceuticals, pressurized gaseous chemicals, or other contraband shall be confiscated at Park™ entrance and patron fined market value for such items.
3. Accept entry into the Rite of Kings Sweepstakes while on park premises. Rite of Kings Sweepstakes is open to all natural persons who enter the Park™. Limit one entry per patron, per visit. Grand Prize Winners agree to be contacted personally by the Chief Executive Officer of Parent Corporation SYNGEN and agree to accept Grand Prize.
4. Release, discharge, and promise not to sue Park™ or Parent Corporation SYNGEN including any subsidiaries thereof. I/my minor child agree to indemnify and hold harmless the Parent Corporation in the event of any of the aforesaid injuries, death, or financial loss occurs, including the intentional negligence of the Parent Corporation or Park™.
5. Agree to not extract or redistribute DinoDNA® in any way. Signature of this document shall automatically instill SecureSoft™ security programs within my/my minor child's ship(s) in order to prevent inadvertent theft. Photos, drawings (including but not limited to my/my minor child's family photos or drawings of Park™ attractions), or otherwise copying DNA will result in immediate confiscation of I/my minor child's ship(s) and any other property that may facilitate the theft of Parent Corporation SYNGEN's intellectual property.
